- 2- Research should be objective and comprehensive. It should follow a scientific method in terms of depending on original references, documentation and explanation of “Ahadeeth” showing their degree of authenticity.
- 3- Any Research submitted for publication, should not have been published in either a book, a journal or any other means of publication.
- 4- Research should be concluded by brief summary manifesting results and opinions included therein.
- 5- An abstract of the article in English should be attached with the research paper.
- 6- Research will be forwarded for peer review to two experts, nominated by Patron-in Chief.
- 7- Pages of research should be at least fifteen of the journal.
- 8- Researcher’s name should be written in complete along with current position, if any.
- 9- Researches, which are not be published, will not be returned.

Note: All researches published in “Ma’arif-e-Islami” express the viewpoints of their authors.
